A family's best resources are people who already know them. Call and talk with a lawyer you know from work, church or your community. Ask – "If this were your child and situation who would you use?" This is a great way to get a referral.

Ask what the service will cost. Lawyers charge \$150 to \$250 an hour. The range of prices for Guardianship is \$1000 to \$2000. If an attorney's quote seems to be extremely high he/she may not be interested in the work or have expertise in guardianships. You may want to check elsewhere. Keep interviewing and get quotes from 3 or more sources.
